Ellis is proud to be among just six percent of early childhood programs nationwide accredited by the National Association for the Education of Young Children (NAEYC).

Due to its high level of quality, Boston Public Schools (BPS) funds four Ellis preschool classrooms as part of its Boston Pre-K (formerly Universal Pre-K) program.

Ellis partners with the New England Conservatory to provide weekly, developmentally appropriate music classes to all 22 of our classrooms, including those for infants.

Ellis has two STEM labs for toddlers and preschoolers, designed to look like children's playhouses, at our South End campus.

Ellis is beloved and has a waitlist of over 1,200 children due to our high quality, rich diversity, and warm learning environment.



Outgoing Board Chair Coleen Downs Dinneen

An Extraordinary Leader at an Extraordinary Time

Both modest and fearless by nature, outgoing Board Chair Coleen Downs Dinneen was the leader Ellis needed to navigate the pandemic and seize the growth opportunities that arose soon after.

Coleen discovered Ellis as a holiday volunteer from Natixis, and it was love at first sight. “All Ellis children are my children,” she later said. Coleen joined the Board in 2007 and became Chair in 2019, shortly after Ellis CEO Lauren Cook arrived. They became a closely knit team that overcame obstacles and brought Ellis to a new level.

Less than a year later, the pandemic struck. Though so much was uncertain and unprecedented, Coleen never hesitated. The state mandated a three-month closure, but Coleen helped keep Ellis teachers paid and parents and children engaged. When Ellis planned to reopen on July 1, 2020, Coleen helped with a steady hand. “There were no guidelines, no vaccines, and lots of fear,” Lauren recalls. “Coleen did so much to figure out how to run classrooms safely.” She helped ensure a smooth reopening, even running a test simulation the day before.

An attorney by training, Coleen knew how to navigate risks and requirements. She helped set the necessary but painful regulations preventing parents from entering Ellis when the school was open but in lockdown, and she stayed calm and measured as she helped staff and parents navigate this new world. “Coleen is the best advice giver,” Lauren says. “She is thoughtful and attentive, she never makes you feel inadequate or unprepared, and she always opens you to new possibilities.”

At the same time, Lauren was pregnant and preparing for maternity leave. Coleen saved the day. In August 2020, she offered to be the acting CEO, onsite three days a week. “This was the biggest gift she could give me,” Lauren says. “She came out of retirement to give me time with my baby, and as hard as everything was, she made it as easy as it could be.”

Patti Keenan, Vice President of Advancement, Community, and Equity, was a new employee when Coleen became Acting CEO. “Coleen provided seamless management when Lauren was out,” she says. “I had development but not child care experience. Coleen knew everything about Ellis and helped me learn how to do my best for the organization.”

After this trial by fire, Coleen became invaluable because she knew more about Ellis than the typical Chair. When Lauren presented the opportunity to expand into Jamaica Plain, Coleen was quick to participate in the blue-sky thinking, careful planning, and close attention to compliance requirements. With Lauren’s vision and Coleen’s management, legal, and financial skills, the project was a success. Ellis JP opened in 2021, bringing its high-quality education and care to 61 additional infants, toddlers, and preschoolers.

Lauren and Patti agree that Coleen’s many achievements spring from her deep feeling for Ellis. This supremely well-organized lawyer and planner has super powers that come from the heart. When she stepped down as Board Chair in 2025, Coleen left a legacy of steady leadership, fearless problem-solving, and deep care for every child at Ellis. Her successor, Jim Geraghty, acknowledges his debt to her. “I admire all Coleen has achieved and look forward to building on her success,” he says.

The Aguilar Family Finds a Second Home at Ellis



In 2020, when Eyleen Aguilar saw signs announcing that Ellis Early Learning was coming to the neighborhood, she was overjoyed. “I grew up in the South End, so I knew about Ellis even when I was a child,” Eyleen says. “I knew what a special school it was.”

At the time, her oldest son, Noell, was in the fourth grade, and her second son, Phenix, was in a small Spanish-speaking, home-based child care program. Eyleen soon realized that Phenix needed more stimulation and learning in his day.

"I signed him up for Ellis, but we were behind more than 100 children on the waitlist, and I thought we'd never get in," she recalls. Then her youngest son, Eyce, was accepted into the infant room. Because Ellis works hard to keep families together, both brothers were able to start at the same time, at five months and four years old.

From the beginning, Phenix thrived. He loved his Thursdays with Phil Berman, "Mr. Phil," Lead Faculty and Program Coordinator for the New England Conservatory's Early Childhood Education music program. Mr. Phil visits every Ellis classroom to lead weekly music sessions where the children sing, dance, and build the broad developmental skills that music fosters.

"Mr. Phil is super popular in our house," Eyleen says, "Phenix sings many Mr. Phil songs at home."

She also applauds a six-week, social skills program that helped Phenix learn to identify and name his feelings. Eyleen knows this skill will serve him well as he starts kindergarten this fall.

The Aguilars' youngest, Eyce, is more reserved, but at Ellis he feels at home with his teachers.

"The infants are always active, with crafts, circle time, and music," Eyleen says. "I get photos, I get videos, I get detailed reports on eating, diapers, routines. I really feel on top of my boys' days."

Beyond the classroom, Eyleen values the Ellis community. She attended Ellis's Cheers to Community event at The Haven in Jamaica Plain. The event made a deep impression in some unexpected ways. "We are a low-income family whose children attend Ellis on vouchers," she says. "At that event, I understood for the first time how outside support from donors makes Ellis possible."

Eyleen and her husband Wes couldn't be more enthusiastic. "It's like a big family — of teachers, other parents, and other children. All the teachers know all the children, not only by name, but by their personal preferences. The staff encourages the parents to connect with each other. There couldn't be a more caring place."

Morgan and David DesPrez Make Ellis a Family Affair

For the past decade, Morgan and David (above) have lived in the South End and are deeply committed to the neighborhood. When Morgan was pregnant with their son Jay, friends sang Ellis’s praises, so the two eagerly joined the waitlist. But the list was long, so they enrolled Jay elsewhere. Soon, the pandemic turned everything upside down. As child care centers closed and families left the city, Morgan and David got a call: Ellis had an opening.

The opportunity thrilled Morgan and David, but COVID-19 protocols prevented parents from entering the school. “We couldn’t see the classrooms,” Morgan says, “but we knew members of the community and Ellis’s reputation. David and I were happy to enroll Jay.”

They have never looked back. Since 2020, the two have fully embraced Ellis, enrolling all three of their children and supporting the school in every way they can. David joined the Board of Directors in 2024, and Morgan serves on Ellis event host committees and often chaperones the annual Swan Boat outing.

After a brief experience with another center, Morgan and David were quick to appreciate the stimulating educational programs that set Ellis apart. “Our children are exposed to challenging concepts,” Morgan says. “We’re seeing curiosity all the time.”

That curiosity shines through Ellis’s creative, play-based academics. Jay once participated in a cooking-themed unit that included making pizzas, setting up a classroom grocery store, and visiting a local market. The food focus has continued with Zoë, the youngest, who brings home vegetables from the Ellis garden. Morgan praises the “very unique programming — interactive, healthy, and educational!”

Music is another favorite program.

Daughters Antonia and Zoë have been so enamored with Mr. Phil that they refused to be picked up until his class ended. Morgan has learned to time her arrival appropriately.

Beyond the curriculum, Morgan and David treasure the sense of community that defines Ellis. “The entire staff is one cohesive team, from Lauren on down,” Morgan says. She and David marvel that, no matter which Ellis teacher or staff member is present for pick-ups and drop-offs, they always recognize their children by name, making them feel part of the community.

David’s service on the Board reflects that same commitment to the Ellis mission of high-quality early childhood education for everyone and support for educators. “I wanted to understand why Ellis has been so successful and contribute to its future growth,” he says. As a member of the Development Committee, he is focused on helping Ellis expand its corporate partnerships.

Even after their two oldest children have graduated, the DesPrez Family remains deeply involved. David plans to continue on the Board when Zoë graduates in 2026. “We are proud to be part of the neighborhood and the school,” he says. “Our goal is to do anything we can to make Ellis as impactful for other families as it has been for us.”



A Place to Stay, A Place to Grow

Honoring Ellis's Longest-Serving Educators



Early childhood educators are more than teachers; they are a second family to the children they serve. At Ellis, our educators make every effort to ensure that every child thrives through thoughtful, nurturing care. The teachers' consistency and compassion form the heart of Ellis's mission: helping Boston's children and families build strong foundations for the future.

Across Massachusetts, early education programs face annual teacher turnover rates as high as 30–40%, according to a 2024 report from the Boston Opportunity Agenda. The demanding nature of the work, low pay, and limited support make it difficult to hire and retain staff. Even at Ellis, which works to raise compensation, provide mentorship and professional development, and create a network of support so educators can build lasting, meaningful careers, those who stay a decade or more are truly worth celebrating.

In this environment, the dedication of our longest-serving educators and the extraordinary commitment of four Ellis teachers is a testament to the care they show the children

and families they serve. Aletssandra (Sandra) Jesus, Lisa St. Hill, Jeannie Chalek, and Alevitssandra (Levi) Jesus (photographed to the left, listed in order of appearance) have each taught in the South End for more than a decade. For these longtime educators, Ellis isn't just a workplace, it's a community.

Lisa St. Hill, who has been at Ellis since 2006, explains, "Ellis has that family vibe. It's much more than just a job." Early in her time at Ellis, Lisa's mother died. With her father far away in Trinidad, Leo Delaney, the former CEO, stepped in as a father figure. "His door was always open, and he would always come and check in on me," Lisa says. "That kind of support makes all the difference."

Today, Lisa works in the Breakers Classroom with toddlers transitioning into preschool, but she treasures her time as a "float" teacher when she was just starting at Ellis. "I've worked with everybody! Anytime a classroom needed coverage, I would just go. It gave me the chance to really understand all the children and all the teachers."

Jeannie Chalek, who came to Ellis in 2012 after many years as an early childhood teacher, says that the positive classroom environment and supportive atmosphere keep her at Ellis. "With smaller classrooms and intentional teacher matching, we can give each child the attention they need," she explains. "The carefully planned structure benefits both the teachers and the students." More than that, Jeannie adds, "Ellis is your second family. You're not just a body here — you're valued."

Circle time is a highlight of Jeannie's days. "We gather as a group, check how we're feeling using the emotions board, sing songs, and read stories. It's a special time to connect. And the kids really make your day; they make you want to come in every morning."

Twins Levi and Sandra Jesus came to Ellis South End within months of each other, and both found a home and a purpose. Levi and Sandra always had a love for children. When Levi saw a volunteer opportunity at Ellis, she said, "I think that's for me."

Levi began volunteering in 2013, and gained valuable experience by floating to different classrooms, working with babies, toddlers, and preschoolers while she waited for a full-time opening at Ellis. She recalls a heartwarming moment when she realized her impact on the students.

A child in her classroom started screaming and crying when she was dropped off, distressed when she didn't see her teacher. "They had to bring the child to me before she finally calmed down. Seeing that bond tells you that you've made a real impact. That feeling stays with you," Levi says.



Sandra joined Ellis soon after her twin sister and now leads a classroom of toddlers in Pollywogs. She loves watching her students light up during music and hands-on STEM lessons. "It's amazing to see their personalities emerge and their independence grow," she says.

For over a decade, Jeannie, Sandra, Levi, and Lisa have shaped countless young lives. Their dedication and care exemplify the mission of Ellis Early Learning: to nurture the whole child and support families in building strong foundations for the future. As they continue to teach and inspire, their legacy is felt not just in the classroom, but in the hearts of the children who carry their lessons forward.

Living Well, Doing Good

Kate and Tom Kush's Lasting Gift to Ellis

At the start of the year, Kate Kush made a simple yet powerful resolution: to live well and do good. For Kate, living well means embracing life fully and finding joy. Doing good means giving back. Together with her husband, Tom, she turned that intention to do good into action. As the couple deepened their engagement with Ellis Early Learning, they chose to leave a lasting mark, designating Ellis as a beneficiary of a future legacy gift.

If you've ever read an Ellis newsletter story or team member profile, you've already met Kate. A versatile writer, she and Tom both earned their Ph.D.s in English from the University of Michigan. In 2019, Kate was introduced to Ellis by CEO Lauren Cook. The two had first met a decade earlier as regular early birds at a local gym.

When Lauren joined Ellis in 2018, she felt Kate might also be moved by its mission. She invited Kate to lend her writing expertise to Ellis's newsletters and annual reports. Kate was deeply inspired by what she learned through her writing. As Tom also came to know the organization, he was moved by the same mission and vision.

As Kate interviewed parents, teachers, and staff, she uncovered dozens of remarkable stories that revealed what makes Ellis unique. "At first, I got involved because I admired Lauren," she says. "But I stayed because Ellis was extraordinary." The first time they attended an Ellis benefit together, Tom, hearing these stories and witnessing the community alongside Kate, became emotionally invested as well.

Over time, the Kushes became a trusted part of the Ellis community. This summer, Kate joined the Board of Directors, as she and Tom deepened their commitment to the mission.

"We have been on a long journey together as Kate and Tom got to know us and the early education sector," said Ellis CEO Lauren Cook. "I was so honored that Kate felt she was ready to join the Board of Directors."

Through their involvement, the Kushes have seen Ellis's distinct impact: from the waitlists that prioritize children in greatest need, to the Jamaica Plain location where a 60% Spanish-speaking school body reflects the vibrancy of the neighborhood.

One memory still makes Kate smile: “When I told my South End hairdresser about Ellis, she knew the school right away. She said, ‘When I walk by, I see parents and children from different walks of life, all carrying themselves with the same self-confidence and dignity. There’s some kind of magic that happens inside there.’”

That sense of magic and belonging inspired Kate and Tom to take their commitment further. Together, they chose to name Ellis in their estate plan.

“For a long time, I was reluctant,” Kate admits. “Charities would ask, but I thought I was too young, or that my future was too uncertain. The process seemed complicated, and I wasn’t ready to change my will in this way.”

After attending webinars through the University of Michigan and Fidelity, she realized how straightforward the process could be. Naming Ellis as a beneficiary of her retirement accounts was as simple as specifying a percentage of assets in an online form.

“That flexibility made it feel possible,” she says.

For both Kate and Tom, the decision was deeply personal. They share the belief that education is life-changing, and that Ellis opens doors of opportunity for children and families. Building on this commitment, Kate helped launch the Ellis 1885 Society, creating a way for others to make meaningful legacy gifts that will leave a lasting impact on the early education sector and on Boston’s children and families.

“We are so grateful that the Kushes are willing to stand as advocates for early education,” says Lauren.

“The thought of being able to support Ellis with a final gift after my death, to continue this work, is very positive for me,” Kate says.

For Kate and Tom, naming Ellis in their estate plan is the fullest expression of their shared resolution to live well and do good.

HOW YOU CAN CREATE A LEGACY GIFT

Name Ellis as a beneficiary

You can name Ellis as a beneficiary of almost any account — IRA, retirement, or non-retirement.

Primary vs. contingent beneficiaries

Primary beneficiaries receive funds upon your death.

Contingent beneficiaries receive funds after the death of the primary beneficiary.

Note: Some institutions may not allow contingent beneficiaries, so it is worth confirming.

Flexibility by institution

Some banks allow you to designate a percentage of your account value for each beneficiary.

Other banks may assign the same percentage to each beneficiary.

Percentages are typically the only option since account balances fluctuate.

Online setup

Most financial institutions let you update or add beneficiaries online. This keeps the process easy and under your control.

Other ways to give

You can also name Ellis in your will or as a beneficiary of your life insurance policy.

A Legacy of Leadership

When Jim Alexander was first introduced to Ellis Early Learning in 1988, he could hardly have imagined the 36-year journey that lay ahead, a journey that would help transform a small, little-known child care provider into a nationally recognized model serving over 300 children and families each year, all while keeping accessibility and inclusivity at its heart.

Jim's passion for early education began in Philadelphia. As a father, he experienced firsthand the challenges of securing reliable child care and the transformative impact of excellent early educators. He came to see teachers as essential for lifelong success, an insight that stayed with him when he moved to Boston in 1969.

An architect and preservationist deeply invested in Boston's South End, Jim connected with Ellis through Board Member Roger Tackeff and quickly became a committed leader. He played a key role in purchasing and developing Ellis's 58 Berkeley Street location, served as Board Chair and Development Committee Chair, and helped recruit talented leaders such as Coleen Downs Dinneen.

On the Development Committee, Jim partnered closely with Patti Keenan, Ellis's VP of Advancement, Community, and Equity. "Jim went above Board expectations," Patti recalls. "He was a thought partner, always willing to share his expertise and invest his time to help Ellis grow," she says. "He truly dotes on Ellis, and he extends himself with such joy in everything he does for us."

A consistent advocate for educators, Jim champions fair pay, professional development, and the belief that strong teachers are essential to strong outcomes for children.

In 2025, as he prepared to retire, Jim stepped down from the Board, leading to the creation of the Emeritus Board of Directors — established to honor Ellis's most steadfast champions — with Jim serving as its inaugural president. Reflecting on his service, Jim says, "Seeing children thrive in the diverse early education model at Ellis has been the greatest reward."

Jim's legacy at Ellis is one of vision, stewardship, and an unwavering belief in the power of early education to change lives.

Representative Aaron Michlewitz

Championing Early Education Across Massachusetts

For Boston's children and families, Representative Aaron Michlewitz has been a steadfast champion. A lifelong Bostonian, he has devoted his career to strengthening the city's communities and ensuring every child has access to high-quality early education. From enabling critical state funding to advancing innovative policies, Chairman Michlewitz has been instrumental in shaping the future of early education across Massachusetts.

Elected to the Massachusetts House of Representatives in 2009, Rep. Michlewitz serves the Third Suffolk District, which includes Ellis's South End locations. In 2019, he was named Chair of the Massachusetts House Ways and Means Committee, overseeing legislation affecting the Commonwealth's finances and working with fellow officials to create the state budget.

When COVID-19 struck, early education centers across Massachusetts were profoundly affected. Federal funding from the American Rescue Plan Act (ARPA) helped stabilize the sector through the Commonwealth Cares for Children (C3) grants, but that funding was temporary. Driven by his deep commitment to early education, Chairman Michlewitz ensured the state could continue funding C3 grants beginning in FY2023, helping centers recruit and retain staff, increase compensation, and launch high-quality initiatives at no additional cost to families. He chose Ellis Early Learning as the backdrop for a press conference (pictured right) to announce this historic investment alongside House Speaker Ron Mariano.

A long-time advocate for early education, Chairman Michlewitz helped launch the Early Education and Care Economic Review Commission in 2020, to study the sector's funding structure and recommend initiatives to expand equitable access. The Commission identified a \$1.5 billion investment needed to stabilize the system and fully meet family needs. Chairman Michlewitz has leveraged the report to push for continued growth in early education investments, including the C3 grants, which he helped codify

into statute — an important milestone on the path toward fully funding and stabilizing the early education system.

Chairman Michlewitz has also been a consistent supporter of Ellis. He joined us to celebrate the launch of our South End STEM Labs and the reopening of the Ellis Early Learning Children's Park. Ellis has

celebrated his impact: in 2022, we were grateful to mark his birthday while honoring his contributions to the sector; and he was named our Champion of Early Education at the annual fall benefit in 2023, *Celebrating Ellis and the Strength of Families*.

As we look ahead to the work still needed to expand accessible, high-quality early education across Massachusetts, we are deeply grateful for Chairman Michlewitz's tireless support, willingness to listen, visionary leadership, and advocacy for the investments that children and families need.

Transforming Early Education

Excellence at Ellis and Beyond

Continuing a trend of year-over-year growth at Ellis, FY25 was especially transformative. An extraordinary anonymous gift catalyzed three major initiatives that expand our reach and strengthen our mission of providing high-quality early education for all.

This restricted gift allowed Ellis to dedicate significant capital to expanding access to child care across Greater Boston, and creating the infrastructure to better support both teachers and families. Ten new positions were created to lead and implement this ambitious work.

THREE NEW INITIATIVES

Measurement, Evaluation, and Learning (MEL)

Led by Ellis's first-ever Director of Evaluation and Educational Excellence, MEL builds centralized databases that track family support, educator growth, and child learning outcomes. These insights fuel continuous improvement across our classrooms and programs.

The Center of Excellence (CoE)

Ellis's in-house professional development initiative advancing best-in-class teaching practices and mental and behavioral health approaches to strengthen program quality, support educator well-being, and enhance child outcomes.

The Ellis Family Child Care (FCC) Network

The FCC Network expands Ellis's impact and reach by partnering with licensed family child care programs and providing administrative and business guidance, early relational health support, and professional development to serve more children and families in need.



EDUCATOR EXCELLENCE AT THE CORE

Ellis understands educator excellence is the cornerstone of positive child outcomes.

"Teachers saved me," says Rosa Turco, Ph.D., Ellis's inaugural Director of Evaluation and Educational Excellence. "They encouraged me and lifted me up. Those interactions made all the difference in my life." Today, Rosa leads evaluation at Ellis in close collaboration with the CoE, translating classroom observations into a replicable model of excellence.

"Ellis has given us the opportunity to truly speak out for what children need, what teachers need, and what is really happening in early childhood," adds Allegra Taylor, Director of the Center of Excellence. The CoE team is spending time in classrooms, observing Ellis values in action, and developing shared language that defines and elevates excellence in early education.

To support excellence in family child care, Ellis FCC Network Director Christy Bortolotto leads the Network alongside Gloria Valentin and Chris Loomis. With more than 55 years of combined family child care experience among them, the team of three helps women entrepreneurs build thriving child care businesses while providing safe, nurturing environments for local children.

"When you're starting out as a family child care educator, you're running a business," says Christy, who owned her own family child care practice for 20 years. "You're the teacher, the nurse, the cleaner, the social worker, the chef — you're everything. Having support from Ellis can be life changing."

Through the FCC Network, Ellis leverages its expertise in family support, educator growth, and professional development to strengthen local family child care programs — most of which are run by women of color — helping with enrollment, billing, and business operations.

LOOKING AHEAD

Together, these initiatives mark a new chapter for Ellis: one where data, innovation, and teacher support combine to expand opportunities for children and families. By strengthening our educators, fostering innovation, and building systems of excellence, Ellis is advancing our commitment to give every child the opportunity to learn, grow, and succeed.

Public Investment in Play

The Ellis Children's Park Reopens

In April 2024, Ellis launched a much-needed renovation of the Ellis Early Learning Children's Park on Chandler and Berkeley Streets.

A beloved South End landmark since 2007, the park reopened on a bright September morning with a celebration honoring the partners who made the project possible: the Department of Early Education and Care (EEC), the Baupost Group, and Cathy E. Minehan, former President and CEO of the Federal Reserve Bank of Boston. EEC Commissioner Amy Kershaw and Representative Aaron Michlewitz — champions of the Early Education and Out-of-School Time grant program that provided critical funding — shared remarks on the vital role of early education, calling Ellis a blueprint for equitable, high-quality child care.

The new Ellis Children's Park is specially designed for infants and toddlers, with refreshed turf and a vibrant mural of Boston's Orange Line by artist Sasha Kouzza. The redesigned space features natural wood structures, musical elements, and a platform overlooking the trains below; a view that fascinates our little explorers.

The renovation strengthens our mission to provide joyful, high-quality early learning experiences while enriching the broader community, as the park remains open to all.

CEO Lauren Cook expressed gratitude to supporters: “This space is a great example of how individual, government, and corporate giving can come together to make something magical,” she said, “and shows how important it is to have green, safe places for children to play.”

Growing Curiosity

Introducing Gardening at Ellis

At Ellis this spring, our preschoolers dug their hands into the soil, dropped tiny seeds into the earth, and watched with wide eyes as green shoots appeared weeks later. Thanks to support from the Massachusetts FRESH Grant and PNC Bank, Ellis launched its first gardening program, bringing farm-to-school learning directly to our city classrooms in partnership with Green City Growers (photographed above at our onsite garden).

For many students, this program was their first opportunity to connect with nature and learn how food grows. They tasted new fruits and vegetables, explored the role of insects in the garden, and understood real-world connections to ideas they learn in class.

Aiyauna Terry, Director of BPK and Preschool Education, describes the Ellis Garden Program as an invaluable experience. Kalicia Sears, Director of Toddler and Infant Education at 58 Berkeley, adds that watching the students develop their understanding of the natural world is rewarding for educators: “When the students look at you and it clicks for them — that ‘I grew that’ moment — it really shows the impact of these classes,” she says.

More than gardening, this program grows curiosity, confidence, and pride, lessons our children will carry with them long after the harvest.
